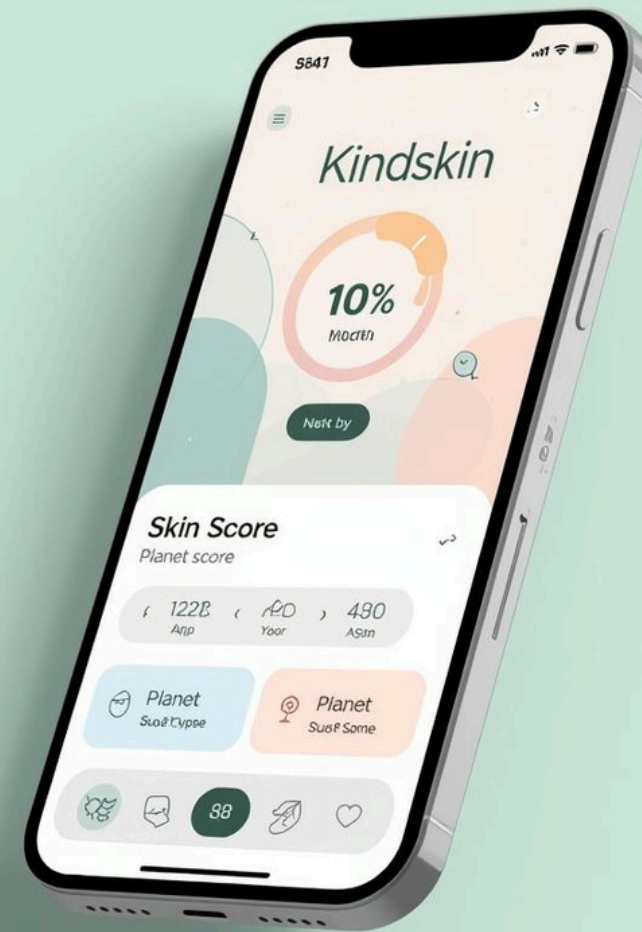
The Hidden Irritants in Our Closets

- People with sensitive skin, eczema, or allergies often react to certain fabrics, dyes, and finishes.
- Clothing labels list fibers but don't explain irritation risk.
- We obsess over skincare ingredients, but we know almost nothing about what touches our skin all day: our clothes.
- Online shopping makes it even harder to guess how a fabric will feel.
- There is no simple, trusted “skin safety” rating for clothing.



KindSkin Solution

- Mobile app + browser extension for in-store and online shopping.
- Scan a tag, barcode, or product link to see a Skin Score and Planet Score.
- Clear tags like “KindSkin Approved,” “Use with Caution,” “Avoid for Sensitive Skin.”
- Scores and recommendations are personalized to your skin concerns and fabric preferences.
- Turns confusing fiber lists into simple, everyday language.



Target Customer

Who KindSkin Serves First

- Women 18–32 with sensitive or eczema-prone skin.
- Live in cities, love fashion, and shop mostly online (Zara, Aritzia, Skims, Mango, etc.).
- Already read labels for food and skincare and follow skin/fashion creators on TikTok and IG.
- Care about sustainability but don't know which fabrics or blends are gentler.
- Love sharing “I found this app...” tips with friends and followers.

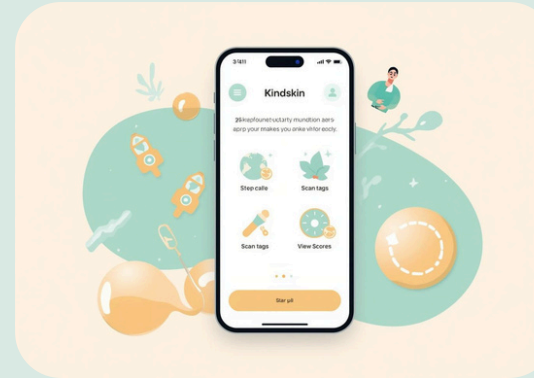
Setting the Skin-Safe Standard

How KindSkin Works in 4 Steps



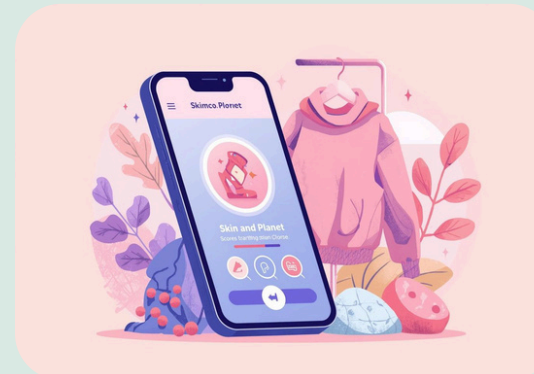
Create Profile
